RAFFLE TERMS AND CONDITIONS

SA Dream Bike Build 10 July 2024

1. DEFINITIONS

- 1.1 These Terms and Conditions (“T&C”) relate to the “SA Dreambike” Campaign.
- 1.2 Clause headings are inserted for convenience only and shall not be used in its interpretation.
- 1.3 The following expressions shall bear the following meanings and related expressions bear corresponding meanings:
- 1.3.1 “**Award Date**” means the date when the draw is conducted and the winning participant is announced by Pedal Project NPC, being **12 October 2024** or such other dates as may be determined;
- 1.3.2 “**Campaign**” means the “SA Dreambike” campaign run by the Pedal Project NPC in order to raise monies for the furtherance of its goals and objectives
- 1.3.3 “**Campaign Period**” means a period **43** consecutive days from the Launch Date;
- 1.3.4 “**Draw**” means the draw to be conducted by Pedal Project NPC on the Award Date;
- 1.3.5 “**Launch Date**” means **30 August 2024**;
- 1.3.6 “**Participant**” means any someone who purchases a raffle ticket;
- 1.3.7 “**Prize**” means **Outer Cycle Ebike, BMC Custom Painted**
- 1.3.8 “**Raffle**” means the campaign raffle in terms of which each Participant stands a chance to win the Prize;
- 1.3.9 “**Ticket**” means a ticket to enter the campaign raffle as purchased on the various online platforms.

2. CAMPAIGN

- 2.1 The Campaign shall run from the Launch Date for the duration of the Campaign Period.
- 2.2 Participants can enter the Raffle at any stage during the Campaign Period.
- 2.3 No Tickets may be purchased after the end of the Campaign Period.

3. HOW TO ENTER

- 3.1 To become eligible as a Participant, a person must purchase a Ticket to enter the Raffle on the dedicated online platform during the Campaign Period.
- 3.2 A Participant can purchase as many Tickets as they wish in the Raffle.

4. THE PROCEEDS

- 4.1 All proceeds due to the Pedal Project NPC from all ticket purchases shall be utilised by the non-profit company in the furtherance of its cause.

5. ELIGIBILITY

- 5.1 The **SA Dreambike** (the "PP Raffle") is open to legal residents of the Republic of South Africa over the age of 18.
- 5.2 All employees of the Pedal Project Non-Profit Company ("PP NPC"), all associated agencies and each of their representatives, distributors, or agents, and their immediate family members and those living in the same household of each (whether related or not), are ineligible to participate in the PP Raffle.
- 5.3 Entry into the PP Raffle constitutes your full and unconditional acceptance of these Official Rules.

6. PP RAFFLE PERIOD

- 6.1 The PP Raffle entry period may be announced via social media platforms, press releases, and email (the "PP Raffle Period").
- 6.2 The winner will be selected from entries properly submitted and timely received during the PP Raffle Period.

7. PP RAFFLE ENTRY INSTRUCTIONS

- 7.1 During the PP Raffle Period, you may purchase and submit as many entry forms as you would like in order to better your chances of winning.

8. PUBLICITY

- 8.1 As a condition of entry into the PP Raffle, except where prohibited by law, each entrant and each winner by accepting a prize grants to PP NPC and its affiliates, legal representatives, assigns and licensees, all right, title and interest in to publicize, broadcast, display and/or otherwise use the PP Raffle entrant's name, city, state, and biographical material (collectively, "Licensed Rights") in any media now or hereafter known throughout the world in perpetuity for advertising and publicity purposes, without additional review, compensation, permission or approval of the winner.
- 8.2 Where necessary, the Prize winner will be required to execute and return an Affidavit of Eligibility/Liability and Publicity Release within twenty-four (24) hours of attempted notification or the winner may be disqualified and an alternate winner selected.

9. SELECTION OF PP RAFFLE WINNER

- 9.1 The potential prize winners will be selected in a random drawing to be held after the PP Raffle period.
- 9.2 The odds of winning will depend on the number of eligible entries received during the PP Raffle Period.
- 9.3 The potential winner will be notified via email to the email address submitted with the potential winner's entry within twenty-four (24) hours after the drawing.
- 9.4 The drawing will be conducted by PP NPC whose decisions on all matters relating to the PP Raffle shall be final and binding.
- 9.5 In the event that a potential winner is disqualified for any reason, PP NPC may, in its sole discretion, award the applicable prize to an alternate winner selected at random.
- 9.6 Any return of prize notification or prize email as undeliverable will result in forfeiture of any prize and an alternate winner may, at PP NPC's discretion, be randomly selected.

10. PRIZE

- 10.1 The prize may be announced via social media platforms, press releases, and email.
- 10.2 The prize will be delivered after the PP Raffle period.
- 10.3 The prize will be delivered to the winning entrant's email address or at the sole option and discretion of the contest PP NPC to a recipient designated by the contest winner.
- 10.4 The prize is not transferable nor redeemable for cash.
- 10.5 All taxes and other charges are the responsibility of the winner. No substitutions are allowed.
- 10.6 All expenses not specifically mentioned herein are not included as part of any Prize package and are solely the winner's responsibility.

11. GENERAL RULES

- 11.1 By entering or participating in the PP Raffle, participants agree to be bound by these Official Rules, and by the decisions of PP NPC, which are final and binding in all respects.
- 11.2 PP NPC is not responsible for:
- 11.2.1 Any incorrect or inaccurate information or technical failures of any kind;
 - 11.2.2 Unauthorized human intervention in any part of the entry process or the PP Raffle; or
 - 11.2.3 Any other computer, network, technical, human or other error, problem or malfunction that may occur in connection with the administration of the PP Raffle, the processing of entries, or the selection or notification of winners.
- 11.3 Further, if, for any reason, the PP Raffle is not capable of running as planned for reasons outside the control of the PP NPC which, in the sole opinion of PP NPC, may corrupt or affect the administration, security, fairness, integrity or proper conduct of the PP Raffle (or portion thereof), PP NPC reserves the right, at its sole discretion, to cancel, terminate, modify or suspend the PP Raffle (or portion thereof).
- 11.4 PP NPC also reserves the right at its sole discretion to disqualify the entry of any individual found to be:
- 11.4.1 Tampering or attempting to tamper with the entry process or the operation of the PP Raffle or any website operated by the PP Raffle Entities;
 - 11.4.2 Using any robotic, macro, automatic, programmed or like entry methods, which will void all such entries;
 - 11.4.3 Violating these Official Rules or the terms of service, conditions of use, and/or general rules of any PP NPC property or service; or
 - 11.4.4 Acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person.
- 11.5 PP NPC is not responsible for claims, injuries, losses or damages of any kind

resulting, in whole or in part, directly or indirectly, from the awarding, delivery, acceptance, use, misuse, possession, loss or misdirection of the prize; participation in this PP Raffle or in any activity or travel-related thereto or from any interaction with, or downloading of, computer PP Raffle information.

12. PARTICIPANT OBLIGATIONS

- 12.1 By participating in the PP Raffle, you agree to be bound by these Official Rules and the decisions of PP NPC.
- 12.2 By accepting the prize, the winner agrees to release and hold PP NPC and affiliates harmless from and against any and all losses, damages, rights, claims, actions and liabilities of any kind in connection with the PP Raffle or receipt or redemption of the prize.
- 12.3 The winner assumes all liability for any injury, death, or damage caused, or allegedly caused, by participating in the PP Raffle or use or redemption of the prize.

13. PERSONAL INFORMATION

- 13.1 By participating in the PP Raffle, Participants consent to:
 - 13.1.1 The use of their name, image and likeness in any footage created by PP NPC as a result of the Participant's participation in the PP Raffle; and
 - 13.1.2 Attending prizegivings and other promotions in respect of the PP Raffle, where requested.
- 13.2 Participants agree that PP NPC may retain the Participant(s) personal information in order to conduct and administer the PP Raffle and for future promotions carried out by PP NPC.
- 13.3 A request to access, update or remove any information should be directed to PP NPC at the address set out above.
